#### Reading of Minutes-April 10, 2023, Regular Meeting

- Judy Carlisle seconded the motion,

- 1. Request Approval and Acceptance of Lochmueller Group Invoice No. 312316-Project No. #214-\$64,187.12- Bedford Spider Creek PS & Storage- Misty Adams
  - Misty Adams requested the board approve the monthly invoice.
  - Judy Carlisle made the motion to approve,
  - Ryan Griffith seconded the motion,
  - All votes were in favor, No One opposed, Approved.

- 2. Request Approval And Acceptance of Midwestern Engineers Inc. Fox Construction Inc. Contract Pay Application No.5 - \$209,470.68- New Police Station - Mayor Sam Craig, Chief Terry Moore, Brandon Woodward
  - Delay in the HVAC system, new ship date is August 2nd.
  - The contractor may need to put temporary A/C units in the building to keep it from deteriorating.

Review and Consideration of Hoosier Uplands Economic Development Corporation Tax Abatement Statement of Benefits (SB-1)- Development of Limestone Edge, L.P.-32-Unit Affordable Housing Complex for Seniors and Seniors with Special Needs-South Shawnee Drive-Recommendation of Time Period, Percentage of Annual Fee, and Organization Distribution to be Approved by the Common Council- Chuck Heintzelman (Milestone Ventures), Natalie Powell (Hoosier Uplands), Greg Pittman
  - Request if for an abatement at seventy five percent for ten years.
  - The city must make host improvements in the amount of \$25,000.
  - Looking at sidewalks or streetlights.
  - Limestone Edge Partnership LLC will be formed after funding is secured with Hoosier Uplands being the main partner.
  - The partnership is a for-profit entity and is subject to property tax.
  - The 2023 taxes for Shawnee Hills Apartments are \$31,490, Stonecutters \$23,567 and Stalker Apartments \$12,321.
